Programme

Introduction to Paleography: lexicon and basic notions. The fundamental stages of the history of handwriting in the Latin world. The dialectic between maiuscule/minuscule and between calligraphic hand/cursive hand. From a unified system to particularism to a newfound unity. Writings of scholars, merchants, notaries in the Middle Ages. The return to ancient models by the Humanists and modern handwritings.

Introduction to Diplomatics: the concept of diplomatic document. Writing, law and documentation system. Basic forms of documents. Read, understand, date and criticize a diplomatic document.

The classroom exercises are intended to: make reading practice of handwritings of various ages and origin; gain confidence with the medieval abbreviation system and with the most common chronological uses in Europe; critically analyze diplomatic documents of various kind and from different periods.

Students will receive other indications on facsimile collections (also online) during the course.

Prerequisites

A basic knowledge of the history of the Latin West (Late Antiquity - Early Modern Age) and an elementary knowledge of the Latin language will be very useful.

Study modes

The practical exercises performed by the teacher in the classroom form an integral part of the course and support the lectures. The practical exercises correspond to 2 ECTS, or 24 hours of application (art. 23, 2nd co., Regolamento didattico Sapienza).

Frequency modes

Non-attending students (all lessons/some lessons) are strictly required to contact the teacher.

Exam modes

The exam consists of an oral test and a practical test linked together, which contribute in equal parts to the evaluation.

The oral exam will consist in the exposition of one or more topics of palaeography and diplomatics discussed in the classroom and/or in the course bibliography. The practical test will serve to demonstrate the student's ability to recognize and read, and also to locate, date, critically analyze (from the historical and cultural point of view) one or more examples of handwriting. The ability to identify the typology of one or more examples of diplomatic document, to recognize and comment on forms, parts or significant elements of the document under examination, to verify dates and computations of dating will also be verified.

The practical test will be carried out on examples not previously illustrated in the classroom.

The assessment will take into account not only the knowledge and skills acquired, but also the autonomy in establishing links between the different topics, the critical and interpretative capacity manifested in the discussion, the mastery of scientific language; the assessment will also take into account the participation in teaching activities during the course. The level of mastery of all these factors will determine the vote.
