#### **ORDERS**

Enrolment of students in the Master Degree Programme in **Product Design in English**, for the 2018-2019 academic year, is subject to the participation in a procedure for the comparative assessment of qualifications.

#### 1. Admission requirements

The procedure for the comparative assessment of qualifications is open to: Italian citizens, EU citizens wherever they may reside and non-EU citizens legally staying in Italy referred to in Article 26 of Law No. 189/2002, and to non-EU citizens permanently resident abroad, to whom a study visa has been issued who, by 14 September 2018, hold the qualifications and meet the curricular requirements below:

- Bachelor Degree or Degree Diploma, or other qualifications gained in Italy or abroad regarded as equivalent. Specifically:
  - for the Degree gained in Italy (by Italian citizens, EU citizens and non-EU citizens resident in Italy) the valid degrees are Industrial Design (class L-4, ex L-42), Industrial Engineering (class L-9, ex L-10), Civil and Environmental Engineering, (class L-7), Architecture (class L-17, ex L-4), Building Sciences and Techniques (class L-17), Information Engineering (class L-8, ex L-9);

- for the Degree gained in EU and non-EU Countries the valid academic fields are:
   Design Degrees, Industrial Engineering Degrees, Information Engineering Degrees,
   Architecture Degrees;
- English language certificate (minimum level B2) or a self-certification of the aforementioned certificate.

All the requirements listed above are an essential condition to enrol in the Master Degree Programme.

In addition to holding the qualifications needed and meeting the requirements listed above, non-EU citizens permanently resident abroad must have submitted a regular preregistration application to the Italian Representation in their country in order to obtain a study visa. Further information is available on the website of the Ministry of Education, University, and Research at http://www.studiare-in-italia.it/studentistranieri/

Students already holding a Second Cycle academic qualification (gained in Italy or abroad) and students coming from other degree programmes or university diplomas must follow the same procedures indicated in the points below and participate in the comparative assessment procedure.

The comparative assessment procedure is also open, subject to gaining the qualification needed, to students exclusively coming from Sapienza University of Rome that are going to gain their Bachelor Degree in Industrial Design by 18 January 2019.

Students who want to register, subject to the above-mentioned condition, must have an English language certificate (minimum level B2) or a self-certification of the aforementioned certificate.

The University may, in any case, adopt exclusion or disqualification measures for candidates who, upon verification, turn out not to satisfy the requirements needed.

#### 2. Number of places available

The number of places available for Italian citizens, EU citizens wherever they may reside, and non-EU citizens permanently resident in Italy referred to in Article 26 of Law No. 189/2002 is equal to **30**.

The number of places available for non-EU citizens permanently resident abroad is equal to **30** (2 of which reserved for Chinese citizens in the "Marco Polo" project).

Any of the places available for non-EU candidates not staying in Italy that are not assigned will be used for the ranking updates regarding Italian citizens, EU citizens wherever they may reside and non-EU citizens permanently resident in Italy referred to in Article 26 of the Law No. 189/2002.

### 3. Deadlines and procedures to take part in the comparative assessment procedure.

Taking part in the comparative assessment procedure is subject to:

**a)** registering on the online computerized system of the University, Infostud, at https://www.studenti.uniroma1.it/phoenixreg/index.html

**Please Note.** Candidates that graduated from Sapienza University may use the access credentials they already hold to access the Infostud system.

b) paying a € 35,00 contribution that must be paid at any Italian Unicredit S.p.a. branch from
 17 July 2018 and strictly within 14 September 2018.

To make the payment one must exclusively use the personalised form that has to be printed out through the online computerized system of the University (Infostud), following the instructions indicated at <a href="https://www.uniroma1.it/it/pagina/iscrizione-alle-prove-di-accesso-infostud">https://www.uniroma1.it/it/pagina/iscrizione-alle-prove-di-accesso-infostud</a>.

The payment may also be made online, with a credit card payment (for further instructions on payment methods check page <a href="https://www.uniroma1.it/it/pagina/come-pagare">https://www.uniroma1.it/it/pagina/come-pagare</a>): the online payment must always be processed within the bank's closing hours (15.45 Italian time zone). Payments made using different methods from those described hereby will not be accepted.

On no account will the admission procedure contribution be refunded.

**Please Note:** keep the registration number issued by the computerized system because it is essential for the other stages of the procedure.

**Important:** Possible communications will be sent to the e-mail address that has been given when registering on Infostud. We recommend that candidates verify the address is correct and that they constantly check their inbox. Students that are already registered on the Infostud system must check/enter their e-mail address using the function *User data* > change access data ("Dati utente > modifica dati accesso").

The form is at the same time:

- self-certification of personal data;
- payment slip for the comparative assessment procedure registration.

#### We also specify that:

Only for Italian citizens, EU citizens wherever they may reside, and non-EU citizens legally staying in Italy referred to in Article 26 of Law No. 189/2002, the participation in the comparative assessment procedure is subject to submitting, within 14 September 2018, the comparative assessment procedure application filled in following the schema in Attachment A of the present call for applications, that must be sent by registered post to the following address (only valid for registered post purposes): Università degli Studi di Roma "La Sapienza" Area Servizi agli Studenti – Segreteria studenti della Facoltà di Architettura – Piazzale Aldo Moro, 5 – 00185 – Roma, specifying on the envelope the name and surname of the sender and the following reference: magistrale DP - 29848.

We hereby specify that the documents sent by registered post must arrive strictly within 14 September 2018 (the actual date of arrival will be considered as a valid attestation for this purpose, not the postmarked date).

Applications with incomplete data entail the exclusion of the candidate from the comparative assessment procedure.

Only for non-EU citizens permanently resident abroad holding an educational qualification gained in a non-EU country, the participation in the comparative assessment procedure is subject to having already submitted the pre-assessment application to the Sapienza Portal <a href="http://www2.uniroma1.it/internazionale/incoming/loginDegree.aspx">http://www2.uniroma1.it/internazionale/incoming/loginDegree.aspx</a> and to having already presented regular admission application to the Italian Representations (Embassy and/or Consulate) in the country of residence. Successful candidates, in order to enrol, must necessarily go within the prescribed deadlines (see point 5) to the Office for Students with a Foreign Qualification (see point 8) to have their educational qualification validated and the documents required by MIUR (Ministry of Education, University, and Research) verified.

#### 4. Assessment criteria of individual preparation

The assessment of qualifications will be done having regard to the study plan previously carried out by candidates.

The scoring criteria listed below apply.

- A) Up to 30 points for:
  - the final dissertation for the Bachelor degree considering the grade/narrative grading and its relevance to Design;
- B) Up to 15 points for diplomas or certificates of attendance:
  - postgraduate advanced-courses;
  - masters;
  - workshops.
- C) Up to 15 points:
  - awards in design competitions;
  - participation in exhibitions and national and international organizations,
  - registration of patents and models
  - products that are being produced.
- D) Up to 5 points for the publication of:
  - books as an author or co-author;
  - essay in a volume;
  - articles in national or international journals.

In the event of any tie the student who graduated within the legal duration of the course shall prevail over candidates who graduated outside prescribed time, and in the event of any further tie, the date of the final dissertation shall prevail (in descending order).

#### 4.1 Candidates who register subject to graduation

Students of Sapienza University of Rome who wish to register subject to condition (with the condition being graduating within the prescribed deadline) will be given, in place of the points in point A above, up to 15 points for the average of the grades of the exams they have taken, based on the table below:

NB. The average grade is calculated by adding together the grades of all the exams, the result must then be divided by the total number of the exams taken. The grade 30 cum laude is equal to 31.

# 5. Ranking publication regarding the verification and assessment of qualifications – obligations for successful students and for students who became successful after a ranking update

The ranking for the assessment of qualifications will be published by 21 September 2018 on the academic programmes catalogue <a href="https://corsidilaurea.uniroma1.it/">https://corsidilaurea.uniroma1.it/</a> at the degree programme page. The online ranking will only be published with students' registration numbers, the ranking with the list of names will be available at the Faculty Student Affairs Office. Successful students must carry out the enrolment process within 28 September 2018.

Students of the Architecture Faculty at Sapienza University of Rome that are going to gain their bachelor degree in Industrial Design within **18 January 2019**, if successful, must submit within **28 September 2018**, a declaration of their intention of enrolling (precautionary request).

Candidates who do not enrol within the prescribed deadline or, in the specified event, who do not submit to the Student Affairs Office, the declaration of the intention of enrolling as soon as they graduate, will be deemed to have given up their place, and the places they leave vacant will become available for subsequent candidates in the ranking. For this reason, a ranking update with the list of students who became available with it is going to be published following the deadline calendar below:

Any other ranking updates will be exclusively managed by the Administrative Office ("Segreteria Amministrativa") with e-mail communications sent at the address given when registering on Infostud. **We recommend that candidates check their inbox.** 

#### 6. Enrolment procedures

Enrolment procedures vary according to the different types of students (see below). Enrolment is obtained by paying the first instalment of tuition fees (if owed) for the academic year 2018-2019 to which the regional fee (if owed) and the stamp duty must be added.

Enrolment procedures, the amount of tuition fees, deadlines, tuition fees benefits, deadlines for the presentation of the ISEE 2018 calculation and payment methods are published at https://www.uniroma1.it/it/pagina/tasse-contributi.

Important: the ISEE 2018 calculation must be requested at CAF (Tax Assistance Centre) at least 30 days before enrolment deadlines, that is because new regulations require more time for the releasement of the certification (Dpcm 159/2014).

Payments must be made at any Italian Unicredit S.p.a. branch or online with a credit card payment (for further information on payment methods check page <a href="https://www.uniroma1.it/it/pagina/come-pagare">https://www.uniroma1.it/it/pagina/come-pagare</a>): on the last day available for the payment, the online payment must be processed within the bank's closing hours (15.45).

On the enrolment form, the corresponding degree programme code must also be indicated, this code is the same as the one specified in the present call for applications and that has been used for participating in the comparative assessment procedure: **29848.** 

Successful candidates holding an Italian qualification must make the enrolment payment, within the deadlines prescribed in point 5, using the personalised form that has to be printed from the website <a href="https://www.uniroma1.it/it/pagina/infostud-immatricolazione">https://www.uniroma1.it/it/pagina/infostud-immatricolazione</a> and following the specific instructions.

To enrol, successful non-EU candidates permanently resident abroad must go, within the deadlines prescribed in point 6, to the Office for Students with a Foreign Qualification (see point 8) to submit the documents required by MIUR (Ministry of Education, University, and Research). Within the deadlines prescribed in point 5, they must make the payment printing the payment slip from <a href="https://www.uniroma1.it/it/pagina/infostud-immatricolazione">https://www.uniroma1.it/it/pagina/infostud-immatricolazione</a> and following the specific instructions.

To enrol, successful candidates holding a qualification gained abroad (Italians, non-EU and EU citizens permanently resident abroad, EU and non-EU citizens that have been legally staying in Italy for more that one year) must go to the Office for Students with a

Foreign Qualification (see point 8) to have their educational qualification validated and the documents required by MIUR (Ministry of Education, University, and Research) verified, and must make, **within the deadlines prescribed in point 5**, the enrolment payment, printing the payment slip from <a href="https://www.uniroma1.it/it/pagina/infostud-immatricolazione">https://www.uniroma1.it/it/pagina/infostud-immatricolazione</a> and following the specific instructions.

Successful candidates already enrolled in other Degree Programmes at Sapienza University of Rome, must submit a transfer application to the Student Affairs Office of the degree programme they are coming from, pay a  $\in$  65,00 transfer contribution, as a refund for transfer expenses, and must also pay, **strictly within the deadlines prescribed in point 5**, the first instalment of tuition fees, getting the payment slip from the Student Affairs Office of the Faculty of Architecture (see point 8).

**Please Note:** after having paid the transfer contribution, students will no longer be allowed to take exams for the degree programme they have come from.

Successful candidates coming from other Universities must submit their transfer application to the University they are coming from, and make, within the deadlines prescribed in point 5, the payment for the first instalment of tuition fees, downloading the payment slip at <a href="https://www.uniroma1.it/it/pagina/infostud-immatricolazione">https://www.uniroma1.it/it/pagina/infostud-immatricolazione</a>, and must pay a €65,00 transfer contribution, as a refund for transfer expenses, using the payment slip available at the Student Affairs Office of the Faculty of Architecture (see point 8).

Please Note: after having submitted the transfer application, students will no longer be allowed to take exams for the degree programme they have come from.

Successful graduand candidates that are going to gain their degree before 14
September 2018 must enrol respecting the regular deadlines referred to in Article 5.

Successful graduand candidates who are going to gain their degree between 14
September and 18 January 2019 must present – strictly respecting the deadlines and procedures indicated in point 5 – a precautionary request to be allowed to enrol outside the prescribed time limits. These students must pay the first instalment of tuition fees within 30 days from their graduation to keep the place they have been assigned.

Important: together with the payment slip for the first instalment of tuition fees we suggest you also ask the Student Affairs Office to give you the payment slip for the second and third instalment of tuition fees (the deadlines for which are respectively 21 December 2018 and 29 March 2019) as these payment slips cannot be printed online before the payment for the first instalment of tuition fees has been made.

Successful candidates who already hold an academic qualification and wish to apply for a shortened degree programme or for the validation of credits (ECTS) achieved during the previous degree must submit, to the Student Affairs Office of the Faculty of Architecture (see point 8), a request giving it legal value by placing a €16,00 revenue stamp on it within the deadlines indicated in point 6. Students coming from other Universities must also attach a self-certification of the degree they hold specifying the exams taken, the related Academic Disciplines (SSD) and credits (ECTS/CFU). The assessment of the request is carried out by the Faculty's competent bodies.

#### Withdrawal procedure after enrolment

Students who, after having enrolled, wish to withdraw from enrolment in the degree programme must go to the Student Affairs Office and submit a written declaration to the University Rector, on stamp-impressed paper or on plain paper giving it legal value by placing a  $\leqslant$  16,00 revenue stamp on it. The withdrawal procedure may be submitted at any time.

Students who withdraw from enrolment have no right to receive a refund for the tuition fees they have already paid for.
